#### NOTIFICATION OF OFSTED-STYLE INSPECTION

Seven years ago we were delighted to inform you that Ofsted had judged the school to be Outstanding during the inspection carried out on 9<sup>th</sup> December 2009. Since that time, the school has worked tirelessly to maintain and further improve upon these very high standards, whilst also meeting the ongoing challenges of completing expansion to a full three-form entry school, introducing the new national Primary Curriculum and a new national assessment system.

But, how do we know that we are still an outstanding school?

**Ofsted's view**: Ofsted is still satisfied about the quality of education provided at BHJS and has seen no reason to return to re-inspect (although the school could, of course, be subject to a random inspection at any time). Ofsted regularly checks the school's performance data and other public information about the school, such as Parent View, and monitors the information published on the school website.

**The school's view**: Throughout each academic year, the school carries out its own rigorous self-evaluation taking into account the four areas listed in Ofsted's "Common Inspection Framework":

- Effectiveness of leadership and management
- Quality of teaching, learning and assessment
- Personal development, behaviour and welfare
- Outcomes for children and learners.

The judgements made by the school in all these categories are monitored and challenged both by the Governing Body and also by our externally appointed School Improvement Partner (SIP) who formally visits the school on a termly basis.

An external view: This year, with the appointment of a new SIP who until very recently was also a practising Ofsted Inspector, we have requested that he use this Spring Term visit to carry out an Ofsted-style Inspection, which we think will be both an opportune and beneficial exercise for the school to obtain an up-to-date external perspective on how the school is performing.
